RESOLUTION SETTING NOT-TO-EXCEED  
TAX LEVY FOR COLLECTION IN THE YEAR 2024

WHEREAS, State law requires that prior to September 30, 2023, the City of Sunfish Lake set a not-to-exceed tax levy for collection in the year 2024.

The City hereby sets the not-to-exceed tax levy for collection in the year 2024 as follows:

Total Not-to-Exceed Levy \$804,526

**Final Net Not-to-Exceed Levy \$804,526**


